National Resolutions Committee

- Chairs + V. Chairs of the three Standing
 Committees + Appointees to represent all regions
- Three new resolutions
 - Unmanned aerial Systems (drones)
 - Regulatory reform
 - Development of a plan to comply with the Clean Power Plan
- Amendments to three resolutions
 - Nuclear power
 - Demand-side management programs
 - Impact of regulations on NRECA members

Resolutions cont'd

Forwarded proposed resolution without "support"
 "We also urge NRECA to examine the research and
 determine whether the effects of climate change are
 caused by natural trends and/or man-made actions."

This resolution was adopted by Region 7 in 2014. Was debated and failed at the Orlando annual meeting. Will appear in the Resolutions Compendium in all 10 regional meetings in 2015. Regional action will determine whether it will advance to the 2016 annual meeting in New Orleans.

2016 Retirement Security Plan

- 3% base billing rate increase after no change in 2015 (individual co-ops may see higher or lower rate if their average age changes)
- 2016 billing rates distributed earlier this month
- 8 month billing will continue in 2016
- PIRC Personal Investment and Retirement
 Consulting now widely available to participants in RS
 and/or 401(k) plans
 - 20-person threshold eliminated for no-cost seminar
 - 54% more co-ops received programs

RS Plan Valuation

	1/1/2015	1/1/2014
Funded Ratio - MVA	96%	105%
Funded Ratio - AVA	92%	98%

- Funded Ratios were lower at 1/1/2015
 - Investment returns were less than expected in 2014
 - Actuarial tables adjusted for longer expected lifespans
- Eight month billing will continue for 2015
 - No longer needed to prevent a Deficit Reduction Contribution
 - Helps to lower PBGC premiums

MVA = Market Value of Assets AVA = Actuarial Value of Assets



Section 415 RS Overpayments

- Discovered late in 2014
- Software miscalculations resulted in retirement overpayments to 102 individuals at 57 co-ops in 21 states in recent years
- 3 in Alaska
- Individuals had to return overpayments
 - NRECA essentially gifted back those overpayments, grossed up to cover their income tax liability
- NRECA covered all costs ~\$14M
- All impacted employees are on path to resolution



2016 Group Insurance Plans

- Less than 100 employees: premiums for medical and Rx renewals will increase 1%-6%
- 100+ employees: premiums for medical and Rx renewals will increase based on each co-op's experience; nearly 60% of those co-ops will receive single digit increases
- Dental and vision premiums increase modestly
- Individual co-op renewal rates distributed in mid-August 2015

Rural Electric Safety Achievement Program

- New Speak Up! Listen Up! Program initiated
 - Completed three train the trainer classes
 - Many statewides are moving forward proactively
 - Some states are struggling with resources
 - Expect to provide support/resources for these states
- New online system deployment has begun
 - Training and orientation has had challenges
- Highly successful 2015 Safety Leadership Summit
 - 600 attendees
 - Began "No Text, No Driving" campaign
