

## Alaska Power Association – IBEW Local 1547 Scholarship



Alaska Power Association (APA) and IBEW Local 1547 are offering up to \$4,000 in scholarships for Alaska residents who intend to work in the electric industry and who are enrolled in an accredited Alaska vocational school such as the Alaska Joint Electrical Apprenticeship and Training Trust, the Alaska Institute of Technology, the University of Alaska Fairbanks Community & Technical College, and the University of Alaska Anchorage Technical Vocational Educational Program.

APA is the statewide trade association for the electric utilities that supply power to more than a half-million Alaskans in communities from Utqiagvik to Unalaska, through the Interior and Southcentral, and down the Inside Passage.

The International Brotherhood of Electrical Workers Local 1547 was chartered in Alaska on October 1, 1946. Local 1547 represents a diverse range of construction classifications, including power linemen, inside wiremen, power plant workers and technicians, mechanics, warehouse workers, line clearance tree trimmers and heavy equipment operators throughout the entire state of Alaska.

### Rules of eligibility

- The scholarship is for Alaska residents attending an accredited vocational school in Alaska and who intend to work in the electric industry in Alaska upon completion of their programs.

### Scholarship process

A completed and signed application (on the next page) must be accompanied by:

- An official transcript showing achievement level of the applicant
- Two letters of recommendation
  - One letter from an instructor
  - One letter from a personal reference (not a family member)
- A 250-word essay, including a personal history, which addresses **one** of the following topics:
  - How do you see yourself fitting into the electric industry in Alaska?
  - How have you benefitted from your apprenticeship so far?

**The completed application (see next page) must be received by Alaska Power Association no later than 5 p.m. Friday, July 11, 2025.** It is the responsibility of the scholarship applicant to contact Alaska Power Association to ensure that the scholarship packet was received by the deadline.

The Alaska Power Association Scholarship Committee, in partnership with IBEW Local 1547, will select the finalists based on the merits of the application and support documentation. Finalists may be interviewed.

**The completed application and the supporting documentation (transcript and letters of recommendation) must be received by Alaska Power Association no later than 5 p.m. Friday, July 11, 2025.**

If a hardcopy is delivered, applications should be submitted to Alaska Power Association in a sealed envelope that states, "APA-IBEW Local 1547 Scholarship: Not to be opened until after the closing date." The application and backup materials may also be submitted via e-mail at [scholarships@alaskapower.org](mailto:scholarships@alaskapower.org).

- ☐ A 250-word essay, including personal history, which addresses **one** of the following questions:
  - How do you see yourself fitting into the electric industry in Alaska?
  - How have you benefitted from your apprenticeship so far?
- ☐ Sealed envelope that states, "APA-IBEW 1547 Scholarship Application: Not to be opened until after the closing date."

The scholarship recipients will be publicly announced at the Alaska Power Association 74th Annual Meeting Awards Banquet on September 25, 2025, in Cordova, Alaska. After being selected, the scholarship recipients will be asked to supply a photograph that will be used in a presentation during the trade association's awards banquet. **(Note: APA plans to award scholarships before the start of the fall semester.)**

Scholarship recipients are required to provide the Alaska Power Association Board of Directors with a brief summary of academic achievements and a copy of an official transcript one year after receipt of the scholarship funds.
